Since 1981, the Supreme Court of the Federated States of Micronesia started to bind its own decisions including other selected decisions from the state courts of Chuuk,

Kosrae, Pohnpei and Yap into a ring-binder (loose-leaf) and assigned as a volume with the give name "FSM Interim Reporter". In 2019, a General Court Order (GCO) 2014-03 was issued to amends the GCO 1983-4, § 2 to be cited as in either FSM Intrm. or FSM R. as now can be also called FSM Reports. After 39th years, the FSM Supreme Court Law Library (FSMSCLL) is now republishing the FSM Reports into a booklet that makes more secure, easy to carry around while more safe spaces will be available on the library shelves.

The FSM Interim Reporters and now can also be called FSM Reports is a series of bound case reporters that are the official reports of decisions for the Supreme Court of the Federated States of Micronesia

For the fiscal year 2019, the FSM Supreme Court Law Library (FSMSCLL) started a new project on the FSM Reports to be in a perfect binding (also known as soft cover binding) as shown in the pictures above.
